March 13, 2018

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Marc Dick. Members present: Ralph Dybdahl, Steve Gordon and Dean Koch. Absent: Charles Liesinger.

Chairman Dick led the Pledge of Allegiance.

Chairman Dick called for approval of the Agenda. Motion made by Koch to approve the Agenda as sent. Second by Gordon and motion carried.

The minutes from the February 27th meeting were sent to Board members for review prior to publication. Motion made by Gordon to approve the minutes for publication. Second Dybdahl and motion carried.

Commissioner Reports: none.

Hwy Supt, Mic Kreutzfeldt, asked for a Commissioner to be a member of the Stakeholder's Committee for FHWA Safety Study. Commissioner Koch will represent the Commission. Kreutzfeldt presented #2 dyed diesel fuel quotes to the Board: Stern Oil \$1.9985/gallon, Central Farmers Coop \$2.07/gallon and Country Pride Coop \$2.07/gallon. Motion was made by Dybdahl to accept quote from Stern Oil. Second made by Koch and motion carried. Kreutzfeldt presented 2 utility permits for approval. Motion made by Koch to approve Telephone Utility Permit for Triotel Communications. Scope of Project: bore across 435th Ave to 24618 435th Ave (new house). Second made by Gordon and motion carried. Motion made by Koch to approve 14 Electric Utility Permits for Southeastern Electric Cooperative. Scope of Project: overhead to underground for 16 miles along SD38 from 435th Ave to Montrose. Second made by Gordon and motion carried. The DOT Transportation Commission did award Bridge 44-210-177 (bait shop) project to PCI Roads. Kreutzfeldt informed Board that a steel faced roller is scheduled for replacement and he has quotes from DMI in Sioux Falls. Motion made by Dybdahl to purchase the 2016 DynaPack CC1200 for \$35000 from DMI and declare 1970 Raygo Romper roller, fixed asset #299, as surplus. Second made by Koch and motion carried. Also scheduled for replacement is the 2004 Atlas air compressor and Sully County is interested in it. Motion made by Koch to declare fixed asset #788A, air compressor, as surplus property as it is no longer suitable for purpose acquired and to sell to Sully County for \$3500. Second made by Gordon and motion carried. Kreutzfeldt informed the Board that spring load limits will be posted within the next week, following SDDOT recommendations for this area. Current projects include crack filling and sign inspections.

Motion made by Dybdahl to convene as Drainage Commission. Second made by Koch and motion carried.

No drainage permits.

In other business, Kreutzfeldt informed the Board that a Hutchinson County drainage project is being pursued and will need McCook County Drainage Board approval.

The Board reconvened as Board of County Commissioners.

Commissioner Charles Liesinger joined the meeting.

Geralyn Sherman, Welfare Director, and the Commissioners reviewed Care of Poor cases and the list of lien payments received in February. A Notice of Hospitalization was received from Avera Queen of Peace Hospital (2018-08). Two Notices of Hospitalization were received from Avera McKennan Hospital (2018-09 & 2018-10). Three Applications for Poor Relief Assistance were received from Avera McKennan Hospital on behalf of the patients (2017-44, 2017-45 and 2017-46). Sherman noted that none of the individuals have applied for county assistance. An application for county assistance for burial services was approved.

Motion made by Dybdahl to convene as Planning Commission. Second by Gordon and motion carried.

Tracy Hofer, Zoning Administrator, presented 2 plats for approval. Following review of the Plat Review Forms, motion was made by Gordon, second by Koch, and carried, to approve the 1st Plat by resolution:
