Kreutzfeldt reported that he received one quote for the Courthouse concrete work from Sandine Concrete \$5770.14; placement of sidewalk and curb & gutter. Motion made by Dick to accept the quote. Second Smith and motion carried. Kreutzfeldt presented quotes for herbicides from Van Diest Supply and CHS Farmers Alliance Bridgewater. Motion made by Dick to accept quote from Van Diest Supply. Second Smith and motion carried. Grass damage in road ditches, particularly SW corner, was discussed. Time was spent reviewing the 2012 Bridge Sufficiency Report. Kreutzfeldt reported that the online auction through IQBID for the 1995 Ford LT8000 Dump Truck ended 4/10/2012 and Doug Zelmer high bidder at \$13,300.00; \$931.00 commission fee paid by County. Kreutzfeldt reported that Sterzinger Crushing

has completed gravel crushing project at Fendrich/Roling pit, tow power lines needed to be moved with County and Rich Roling sharing cost equally. Motion made by Scharffenberg to authorize Chairman Butzke to sign two original Funding Exchange Agreements. The State will exchange the County's STP Funds for federal fiscal year 2012 with an equal amount in state highway funds. Rather than making a federal fund sub-allocation of \$136,188.91 to the County's STP account for federal fiscal year 2012, the State will transfer state highway funds to the County for allocation into the County's road and bridge fund in the amount of \$136,188191. Second Dick and motion carried. Kreutzfeldt asked that a bid letting date to close the Lehrman Lake be set. Motion made by Dybdahl to set 9:10 a.m., Thursday, June 7, 2012, as time for accepting bids to close the ditch at Lehrman Lake. Second Smith and motion carried.

Motion made by Dick to convene as Drainage Commission. Second Dybdahl and carried.

At 9:30 a.m. the drainage hearing tabled from the April 3<sup>rd</sup> meeting was continued: Permit #12-003, applicant Ronald Addy. Present: Drainage Adm Kreutzfeldt, Dustin Addy, Daniel Lauck, and Tom Lauck. Motion made by Dick to approve this drainage permit and authorize Chairman Butzke to sign same, because the Board couldn't foresee any adverse effects to be created by the proposed project. Drainage Board also recommends that Canistota Township clean out culvert outlets located on 260<sup>th</sup> St just west of 444<sup>th</sup> Ave. Second Smith and motion carried.

Drainage Adm Kreutzfeldt presented drainage permit applications, noting that downstream landowner signatures were obtained and he has signed off on them: Permit D12- 009 Taylor Osterberg, applicant; project description: spot tile east 20 acres,

NE4SE4, Sec 3-104-54 (6" mains with 2 outlets to permit D12-017). Permit D12-017 C & E Family Farms, applicant; project description: spot tiling with 6" mains & 5" laterals with 3 outlets to blue line waterway on same property (approx. 60 acres), NW4SE4 & SW4 3-104-54.

of outlet end, not all the way along the project. Smith asked Gerlach to contact an attorney who specializes in drainage law and report back to the Board at the May 1<sup>st</sup> meeting.
