December 22, 2015

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Ralph Dybdahl. Members present: Marc Dick, Ron Scharffenberg and Sheldon Butzke. Absent: Steve Gordon.

Chairman Dybdahl led the Pledge of Allegiance.

Chairman Dybdahl called for approval of the Agenda. Motion made by Scharffenberg to approve the Agenda as sent. Second made by Butzke and motion carried.

The minutes from the December 8th meeting were sent to Board members for review prior to publication. Chairman Dybdahl called for approval of same. Motion made by Dick to approve the minutes for publication. Second Butzke and motion carried.

Commissioner Reports: none.

Steve Gordon joined the meeting.

Mic Kreutzfeldt, Hwy Supt, and the Commission discussed installation of the camera surveillance system and location of cameras with regard to fuel dispenser system at Hwy Dept. No action taken. Dick noted that this needs to be discussed further. Kreutzfeldt informed Board that the City of Montrose has been awarded a grant for improvements to Clark Street (also Co Rd 10) if they choose to accept it. Kreutzfeldt reported that the Signing Project for McCook County, municipalities and townships was award to Hamm Construction of Ironton, MN, in the amount of \$1,215,484.10. Current projects include taking inventory, sign inspections and cutting brush and trees.

Auditor Sherman noted that the proposed 2016 Hwy Dept payroll increases need to be approved at this time. Motion made by Dick to approve the proposed payroll

increases as presented by Hwy Supt Kreutzfeldt, second by Butzke and motion carried. The hourly payroll rates will be published the first meeting of January 2016.

Motion made by Butzke to convene as Drainage Commission. Second made by Gordon and motion carried.

Drainage Administrator Kreutzfeldt presented one drainage permit application for approval, noting that the permit doesn't include SD Dept of Transportation acceptance. As per policy the Drainage Commission must act on permits lacking SDDOT signoff. John Schallenkamp joined the meeting to present information for the drainage project regarding Permit D15-032, applicant Richards Farms, legal description E2NW4 Section 10 Bridgewater Twp. Following discussion, motion was made by Scharffenberg to approve the permit with following conditions noted: prior to 12-31-2016 a tile bore south under SD262 & Railroad must be approved & installed or a shut-off valve must be installed on tile outlet to slough in NW4NW4 10-101-56. Second made by Gordon and motion carried.

Board reconvened as Board of County Commissioners.

Brenda Colome, Dept of Legislative Audit, met with the Commissioners to let them know that she's started the audit for McCook County, years 2013-2014. Colome presented an engagement letter for signature. The fiscal year 2016 rate of \$63.50 per hour will be charged for this audit. Motion made by Scharffenberg to authorize Chairman Dybdahl to sign the engagement letter. Second by Gordon and motion carried.

Welfare Director Sherman and the Commissioners reviewed Care of Poor cases.

An Application for County Assistance was tabled pending receipt of more information

(2015-49). Avera Queen of Peace Hospital is appealing denial of payment for cliam

(2015-13). Admission of Service completed for Sanford USD Medical; no information from patient (2015-56).

Auditor Sherman presented note dated December 10, 2015 which stated "John Heiberger stopped in Auditor's Office to give us his verbal resignation effective December 15, 2015, due to health issues". Motion made by Butzke to accept the resignation of John Heiberger effective December 15, 2015. Second by Scharffenberg and motion carried.

Tracy Hofer, Dir of Equalization, joined the meeting. Motion made by Dick to enter into Executive Session at 11:00 a.m. to discuss personnel issue. Second by Gordon and motion carried. Chairman Dybdahl declared out of Executive Session at 11:15 a.m. Motion made by Dick to set beginning FT salary for Susanne Arnold at \$31182, effective December 21, 2015 (current pay for office deputy with three years' experience). Arnold will receive the 2016 payroll increase as determined by Dir Hofer; effective January 1, 2016. Second Gordon and motion carried.

Auditor Sherman presented Combined Election Agreement between Salem City and McCook County for Board approval and Chairman signature. The purpose of this agreement if for the parties to conduct their individually required elections in one combined election which will be held on June 7, 2016 which is the date of the regular primary election. Elections are being combined to save tax dollars and to encourage better turnout. Motion made by Butzke to authorize Chairman Dybdahl to sign the agreement. Second by Gordon and motion carried.

The 2016 Court Appointed Attorney fee will be \$92 per hour and mileage will be paid at the rate of \$1.00 per mile.

The November Law Enforcement Report was noted and filed.

The November Clerk of Courts Report was noted and filed.

A Thank You for an increase in funding was received from the McCook County Conservation District; the funding is appreciated because it does make a difference.

Auditor Sherman asked the Board to discuss and make a decision on the 2016 hourly pay increase for part-time employees. Motion made by Dick to increase part-time pay \$.25 per hour for 2016. Second by Gordon and motion carried.
