February 10, 2015

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Ralph Dybdahl. Members present: Marc Dick, Ron Scharffenberg, Sheldon Butzke and Steve Gordon.

Chairman Dybdahl led the Pledge of Allegiance.

Chairman Dybdahl called for approval of the Agenda. Motion made by Butzke to approve the Agenda. Second Gordon and motion carried.

The minutes from the January 27th meeting were sent to Board members for review prior to publication. Chairman Dybdahl called for approval of same. Motion made by Dick to approve the minutes for publication. Second Butzke and motion carried.

Commissioner Reports: Dybdahl reported that he attended 1st Dollar of profit presentation for Finnell Trucking in rural Turner County; a business assisted by Southeast Enterprise Facilitation Project.

Hwy Supt, Mic Kreutzfeldt, presented documentation for Project No BRO 8044(07) PCN 01DV (Bridge #144-101-110 (255th St & 440th Ave). The estimated cost of this project is \$500,059. The cost of the project will be covered by 80% Federal participation and 20% County matching funds. Motion made by Scharffenberg to authorize Chair Dybdahl to sign the Right-of-Way Certificate, Utilities Certificate and Letting Authorization for the project. Second made by Dick and motion carried. Kreutzfeldt presented the 2015 County Striping Program agreement to the Board. County participation in the project is for approximately 54 miles of striping at an estimated cost of \$38,948.40 for County share of project cost. Motion made by Butzke to authorize Chairman Dybdahl to sign 2 original P 000S(00)024 PCN 02SR, 2015 County Striping Program Agreements. Second made by Gordon and motion carried.
Kreutzfeldt informed the Board that SD Federal Property Agency is holding a 1998
Caterpillar excavator for the Hwy Dept until tomorrow. The cost of the machine is
\$39,000 and it has logged 7000 hours. Following discussion, motion was made by
Gordon to approve the purchase of the excavator. Second by Scharffenberg and motion
carried. Current projects include crack sealing and night-time sign inspections.

No new drainage permits.

Discussion was held on progress of the Miner County tiling project affecting Pearl Township. No action taken.

Motion made by Dick to approve applications for Commercial Garbage Hauler Licenses for RBS Sanitation Service and Addy Disposal and authorize Chair Dybdahl to sign both. Second made by Gordon and motion carried.

Auditor Sherman, Mariann Oyen, Benefits Specialist, and the Commissioners reviewed and discussed Care of Poor cases. Mike Fink, States Attorney, and Mark Norris, Sheriff, were present for discussion of one case. One Notice of Hospitalization was received from Avera McKennan Hospital 2015-04. No action taken on an application for burial assistance 2014-58.

Tracy Hofer, Zoning Administrator, presented a plat for approval. Jim Koch was present. Following review of the Plat Review Form provided by Hofer, motion was made by Butzke, second by Gordon, and carried, to approve the following resolution:

"BE IT RESOLVED by the County Commission of McCook County, South Dakota, that the plat of Tract 1 of Koch Addition in the South Half of the Northeast Quarter of Section 11, Township 103 North, Range 54 West of the 5th Principal Meridian, McCook County, South Dakota, be and the same is hereby approved.

Ramon Shultz, TechSolutions, met with the Commissioners to give explanation of Managed IT services that are offered by TechSolutions. Tracy Hofer, Dir of Equalization, Carol Lauer, Treasurer, and Laurie Schwans, Register of Deeds, were present. Auditor Sherman noted that some departments have no one to turn to when problems arise; adding that TechSolutions will assist but only when they've taken care of their contracted customer needs. Sherman added that it's time to be proactive with IT needs and contracting will be a less expensive approach than hiring an IT person. Sherman noted that the Hwy Dept is also interested in IT services. Schwans stated that she rents all equipment in her office from Microfilm Imaging System and doesn't need IT service. Lauer noted that most of the computers & printers in her office are over 5 years old and she needs the IT service. Hofer noted that her server is 5 years old and needs to be updated.

Motion made by Dick to approve the following Abatements: 2015-02 applicant Perry & Marilyn Schuetz, amount of abatement \$181.60, reason for abatement-should be owner occupied and 2015-03 applicant Evangelical Lutheran Christ Church, amount of abatement \$1205.06, reason for abatement-should be tax exempt. Second made by Gordon and motion carried.

Auditor Sherman asked the Board to consider closing the County Passbook Savings account held at The Security State Bank in Canistota, depositing it in the checking account at First Dakota National Bank. The current balance is \$21,148.69, including \$21.30 interest earned in 2014. Motion was made by Dick to close the Passbook Savings account and deposit it in the checking account. Second made by Scharffenberg and motion carried.
