The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Ron Scharffenberg. Members present: Ralph Dybdahl, Marc Dick, Sheldon Butzke, Bill Smith. Chairman Scharffenberg led the Pledge of Allegiance.

Chairman Scharffenberg called for approval of the Agenda. Motion made by Smith to approve the Agenda. Second Butzke and motion carried.

The minutes from the December 29th meeting were sent to Board members for review prior to publication. Chairman Scharffenberg called for approval of same. Motion made by Dybdahl to approve the minutes for publication. Second Smith and motion carried.

At this time, the meeting was turned over to Auditor Sherman to reorganize as the 2012 Board of County Commissioners. The Auditor called for nominations for a Chairman.

Smith nominated Butzke as Chairman. Second Dybdahl. Dick moved that nominations cease and Butzke be declared Chairman. All voted aye.

Dybdahl nominated Smith as Vice-Chairman. Second Dick. Scharffenberg moved that nominations cease and Smith be declared Vice-Chairman. All voted aye.

Dick nominated Dybdahl as Official Stamper. Second Scharffenberg. Butzke moved that nominations cease and Dybdahl be declared Official Stamper. All voted aye.

Chairman Butzke assumed control of the meeting.

Motion made by Dybdahl, second Dick, carried, to make the following appointments and designations for 2012. To authorize all county officials to attend meetings and workshops within the State of South Dakota, which are beneficial to McCook County.

Hwy Supt, Mic Kreutzfeldt, reported the present inventory value at \$501,408.81; gravel pit inventories \$229,427.56; present worth of fixed assets \$1,207,834.58. The 2011 expenditures on major projects and the ending budgets for Hwy Dept and Weed Dept were reviewed. Kreutzfeldt recommended using the 2011 material rates/pit royalties for 2012 as follows: gravel .85/ton; sand .85/ton; rock .85/ton; black dirt 1.25/cubic yard; clay .50/cubic yard. Kreutzfeldt recommended using the current FEMA "Schedule of Equipment Rates"

\$16.60 + \$650 longevity \$15.35 + \$150 longevity as adopted in September 2011. Kreutzfeldt recommended using the 2011 rates for unscheduled equipment and increasing labor, \$2.00, for 2012 as follows:

Kreutzfeldt recommended using the 2011 rates for Moving Permits (non-divisible loads only) for 2012:

The overweight permits must be approved by the Hwy Superintendent.

Overweight: \$20.00 per day per vehicle

Overweight for 1 year (May 1 – February 14) \$100.00 for gravel roads, approved by Supt (construction companies only).

Flying: \$25.00 per 6 months

Motion was made by Smith to follow the above noted recommendations of Hwy Supt Kreutzfeldt. Second Scharffenberg and carried.

Motion made by Dick to convene as Drainage Commission. Second Dybdahl and carried.

At 9:30 a.m. the Drainage Hearing for Permit D11-127, James Miles, applicant, was held as advertised. Project description: drain 80 acres of NE4 36-104-53 with outlet to be NE4NE4 36-104-53. Drainage Adm Kreutzfeldt presented information regarding the Drainage Permit application. The Dept of GF&P did not sign off as downstream landowner because of possible impact to game production area/s. Andy Gabbert, Habitat Resource Biologist, and Steve VanderBeek, Regional Habitat Manager, were present. VanderBeek noted concerns regarding loss of habitat areas, killing emergent vegetation, loss of grazing acres, maintenance trail to food plot and closed basin. VanderBeek referenced the option for a water control structure which would allow scheduling for water release or filtration structure. Butzke asked Miles if he would consider placement of a water control and/or filtration structure with this being cost shared between him and GF&P. VanderBeek indicated that he would not be the individual giving approval for a cost share project, but these have been done. Smith and Dick commented that they didn't see a negative impact because very few acres are in effect being tiled. Kreutzfeldt recommended that a decision be tabled for 60 days allowing the party's time to work on a

shared project. Motion made by Scharffenberg to table to 9:30 a.m., March 20th. Second Smith and motion carried.

Drainage Adm Kreutzfeldt presented the following drainage permit applications, noting that downstream landowner signatures were obtained and he has signed off of them: Permit D11- 088 Evelyn Schmidt, land to be drained W2W2 16-104-53; Permit D11-089 Francis Kane, land to be drained NW4 21-104-53.

Kreutzfeldt noted that Randy Bunger has requested a hearing for Permit D12-01, land to be drained SE4 4-102-56, due to lack of downstream acceptance signatures. Motion made by Dybdahl to set 9:30 a.m., February 7th as time for drainage hearing. Second Smith and motion carried.

The Board reconvened as Board of County Commissioners.

Hwy Supt Kreutzfeldt presented letter from Dept of Transportation regarding highway funding. The Department is in a position to again offer local government entities the opportunity to exchange their federal fund allocation for state funds for this federal fiscal year. This will be discussed at a future meeting. Discussed Co Rd 21A, milling and overlay project using capital outlay funds and not chip seal road this year.

Motion made by Smith to convene as Drainage Commission. Second Dybdahl and motion carried.

Following a request from the Drainage Commission, States Attorney Gerlach was present to give his opinion regarding requirement of downstream acceptance signatures: when adding laterals to a previously permitted main and when expanding a previously permitted main by adding laterals from other properties. In both cases downstream acceptance signatures are required along and ½ mile beyond the property that the tile outlets. Roger Hofer was present.

The Board reconvened as Board of County Commissioners.

Motion made by Scharffenberg to enter into Executive Session at 10:55 a.m. to discuss a personnel matter. States Attorney Gerlach and Auditor Sherman were present. Second Smith and motion carried. Chairman Butzke declared out of Executive Session at 11:00 a.m.

A call was placed to Ilene Manster, Membership Coordinator, National Assn of Counties, to discuss the NACo Prescription Discount Card Program with the Board. The program is designed for the under-insured and non-insured. Following discussion, the Board asked Manster to send a contract for signature of the Chairman.

Auditor Sherman presented the Advance Tax and Escrow Accounts from Treasurer, Carol Lauer; these to be reviewed monthly by the Commission per our latest Audit.

Auditor Sherman presented a request from Tracy Hofer, Dir of Equalization, to the Board. Hofer is asking that her Planning & Zoning salary be decreased by \$1000 with this amount being paid to Louise Hohn who will be doing secretarial duties for Planning & Zoning. Motion made by Dick to lower Hofer's Planning & Zoning salary to \$4000 and pay \$1000 to Hohn for Planning & Zoning duties; keeping the budget for salary at \$5000. This change is effective January 9, 2012. Second Scharffenberg and motion carried.

Auditor Sherman, Mariann Oyen, Dept Social Services Caseworker, and the Commissioners discussed Care of Poor cases. Four Notices of Hospitalization were received from Avera McKennan Hospital. An Application for County Assistance was approved. Sherman did contact the Regional HUD Office in Sioux Falls and the HUD Office in Mitchell to inquire about expanding their coverage area to include McCook County.

Both offices told Sherman that they are unable to work with McCook County at this time.

Motion made by Smith to re-appoint Janice Bennett and Denise Erickson to 3 year terms on the Hanson-McCook Regional Library Board. Second Dybdahl and motion carried.

The December, 2011 Clerk of Courts Report was noted and filed.

The December, 2011 Law Enforcement Report was noted and filed.

Sherman told the Board that Tom Hofer, Golden View Colony, wants to know if they can proceed or do they need to apply for another building permit. The Commission asked Sherman to take the question to States Attorney Gerlach.
