January 14, 2014

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Bill Smith. Members present: Ralph Dybdahl, Ron Scharffenberg, Sheldon Butzke, Marc Dick.

Chairman Smith led the Pledge of Allegiance.

Chairman Smith called for approval of the Agenda. Motion made by Butzke to approve the Agenda. Second Dick and motion carried.

The minutes from the December 30th meeting were sent to Board members for review prior to publication. Chairman Smith called for approval of same. Motion made by Dybdahl to approve the minutes for publication. Second Butzke and motion carried.

Commissioner Reports: Smith attended a Minnehaha County Regional JDC meeting; still looking to build new facility, \$15,000,000, forty beds.

At this time, the meeting was turned over to Auditor Sherman to reorganize as the 2014 Board of County Commissioners. The Auditor called for nominations for a Chairman.

Butzke nominated Dick as Chairman. Second was made by Dybdahl. Dybdahl moved that nominations cease and Dick be declared Chairman. All voted aye.

Smith nominated Dybdahl as Vice-Chairman. Second was made by Dick. Dick moved that nominations cease and Dybdahl be declared Vice-Chairman. All voted aye.

Smith nominated Butzke as Official Stamper. Second was made by Scharffenberg. Scharffenberg moved that nominations cease and Butzke be declared Official Stamper. All voted aye.

Chairman Dick assumed control of the meeting.

Motion made by Scharffenberg, second Dybdahl, and carried, to make the following appointments and designations for 2014. Authorize all county officials to attend meetings and workshops within the State of South Dakota, which are beneficial to McCook County. Hwy Supt, Mic Kreutzfeldt, reported the present worth of inventory \$685,306.80; present worth gravel pit inventories \$421,809.65; present worth of fixed assets \$1,956,190.00 (excluding buildings). The 2013 expenditures on major projects and the ending budgets for Hwy Dept, Weed Dept and Drainage were reviewed. Kreutzfeldt recommended using the current material rates/pit royalties for 2014 as follows: gravel .90/ton; sand .90/ton; rock .90/ton; black dirt 1.50/cubic yard; clay .75/cubic yard. Equipment rates were reviewed and are on file.

Kreutzfeldt recommended using the 2012 rates for Moving Permits (non-divisible loads only) for 2014:

Over Dimension: \$10.00 per day per vehicle

\$25.00 per year per vehicle

The overweight permits must be approved by the Hwy Superintendent.

Overweight: \$20.00 per day per vehicle

Annual Overweight for 1 year (May 1 – February 14) \$100.00 for gravel roads only,

approved by Supt (construction companies only).

Flying: \$25.00 per 6 months

Motion was made by Butzke to follow the recommendations of Hwy Supt Kreutzfeldt. Second Scharffenberg and motion carried.

Hwy Supt Kreutzfeldt informed Commission of concern voiced by Dustin Addy regarding 80,000# weight limit posted on 447th Ave to Marion. Turner County hosting meeting in February regarding transportation issues in getting grain to Marion. Motion made by Dybdahl to declare two sprayers, fixed assets #558 and 574, as surplus property as items are no longer usable and of no value. Kreutzfeldt presented the 2014 County Striping Program Agreement for approval. The County will be included in the project for the striping of approximately 58.40 miles of County roads at an estimated cost of \$54,989.04 based on this year's estimates. The total of County's share of the project costs is \$42,114.78. Motion was made by Scharffenberg to authorize Chairman Dick to sign 3 original Agreements for the 2014 County Striping Program. Second made by Butzke and motion carried.

No drainage permits.

At 10:30 a.m. bids for "truck chassis" were reviewed. The following bids were opened on Monday, January 13th, with Kreutzfeldt, Commissioner Dybdahl and several vendors present: North Central International \$118,791.00; Sheehan Mack Sales &

Equipment \$106,867.00; Sioux Falls Truck & Trailer \$123,392.00; Sioux Falls Truck & Trailer \$123,260.00; I State Truck Center \$110,451.00. Kreutzfeldt reported that all bids had items out of spec and suggested rejecting all bids and purchase off the Brookings County bid of \$106,685.00. Motion made by Smith to reject all bids for the truck chassis. Second made by Dybdahl and motion carried.

At 10:45 a.m. bids for "hydraulic dump body & equipment" were reviewed. The following bids were opened on Monday, January 13th, with Kreutzfeldt, Commissioner Dybdahl and vendors present: Custom Truck Equipment \$59,752.00 and Northern Truck Equipment \$60,550.00. Motion was made by Smith to table awarding of dump body bids until next meeting allowing Kreutzfeldt time to put out an inquiry to other counties regarding availability of any other truck bids. Second made by Butzke and motion carried.

Motion was made by Smith to set 9:00 a.m., January 21, 2014, for Special Meeting in order to review any new information regarding truck bids and to award the bid for a dump body. Second made by Scharffenberg and motion carried.

Auditor Sherman and the Commissioners reviewed and discussed Care of Poor cases. One Notice of Hospitalization was received from Avera McKennan Hospital. An Application for Assistance with a hospital claim was approved. Sherman noted that the ICAP Office and the Auditor's Office are receiving numerous requests for assistance with Xcel Energy bills and propane.

Brad Stiefvater, EDS Director, presented a report from the Mitchell Regional 911 Center which showed a breakdown of 911 calls received by the Center in 2013 for the contracting counties. Stiefvater also presented Homeland Security Grant information for the purchase and installation of manual transfer switches and a 200A receptacle for generator hook ups at the Bridgewater Fire Hall, Spencer Fire Hall, Montrose Fire Hall and the Canistota Fire Hall. Total cost of \$19824.00.
