July 29, 2014

The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Marc Dick. Members present: Ralph Dybdahl, Ron Scharffenberg, Sheldon Butzke, and Bill Smith.

Chairman Dick led the Pledge of Allegiance.

Chairman Dick called for approval of the Agenda. Motion made by Smith to approve the Agenda as sent. Second made by Butzke and motion carried.

The minutes from the July 15<sup>th</sup> meeting were sent to Board members for review prior to publication. Chairman Dick called for approval of same. Motion made by Dybdahl to approve the minutes for publication. Second made by Smith and motion carried.

Commissioner Reports: none.

Mic Kreutzfeldt, Hwy Supt, presented utility permit for approval. Motion made by Scharffenberg to approve Water Utility Permit for Kingbrook Rural Water. Scope of project: William & Connie Smith water service. Second made by Butzke and motion carried. Kreutzfeldt reported that he has the Corps of Engineers Nationwide 404 Permit for Bridge #44-190-022 (Ramsey Twp) removal project prepared and they need to authorize him to act as the agent. Motion made by Smith to authorize Chairman Dick to sign the Application for Department of the Army Permit authorizing Kreutzfeldt to act in behalf of the County in the processing of this application. Second made by Dybdahl and motion carried. Reviewed and discussed SDCL 31-14-2 Commissioners' responsibility for bridges and culverts, with regard to township upsizing culverts; the policy starting August 1, 2014 will allow Townships to size as determined by their board or agent and

require that any sizing changes be reported to the Hwy Supt. (This can be done at time of culvert purchase). Discussed ½ mile of road that appears on the SDDOT County System (by 1946 resolution) that has been on Township system for more than 20 years, this will be corrected by following proper procedures. Current projects include chip sealing, fog sealing and culvert repairs.

In other business, Kreutzfeldt reported that he contacted a family member regarding the weed complaint received on James Oleson property. The family was aware of the problem and has someone hired to take care of the weed issue. The area of weeds was 70% cut and cleaned up at time of follow-up inspection.

Motion made by Scharffenberg to convene as Drainage Commission. Second by Butzke and motion carried.

Drainage Adm Kreutzfeldt reported that the drainage complaint filed by David Benson is resolved, for now. Discussed the Watershed Task Force proposed plan to have DENR maintain a drainage permit database and have a standardized application process in place for counties.

No drainage permits to note.

The Board reconvened as Board of County Commissioners.

Zoning Administrator, Tracy Hofer, joined the meeting. Hofer informed the Board that she will not be present for their August 12<sup>th</sup> meeting and wanted to make them aware that there is a 2nd hearing for a Rezone, a Conditional Use Hearing and a Variance Hearing scheduled for that meeting. Hwy Supt Kreutzfeldt agreed to be present at the August 12<sup>th</sup> hearings if needed.

Motion made by Butzke to convene as Planning Commission. Second made by Smith and motion carried.

Tracy Hofer, Zoning Administrator, presented information for request to rezone property from Ag to Heavy Industrial. Legal description: the S 385' of W 550' of N 1020', SW4 28-103-55. Purpose of rezone: cement plant. Present for the hearing: Brian Waldner, Golden View Colony, Barney Roling, Marie Haala, and Mic Kreutzfeldt, Hwy Supt. Haala noted that this should be noted as a concrete mixing plant not a cement plant; as cement plant is much more regulated. Roling inquired about haul road designations. Hofer stated that this will/can be addressed at the conditional use hearing scheduled for August 12<sup>th</sup>; today's hearing is for rezoning the location. Hofer agreed that this would be considered a concrete mixing plant, not a cement plant. Motion made by Smith to recommend approval of the rezone request to the County Commission. Second was made by Butzke. Ayes: Smith, Butzke, Dybdahl, Scharffenberg and Dick. Nays: none. Motion carried.

The Board reconvened as Board of County Commissioners.

Alicia Reif, 4-H Youth Advisor, met with the Board to ask permission for Annette VanEmmerik to attend 1<sup>st</sup> day of State Fair, August 27<sup>th</sup>, when judging is held. Approval given.

The June 18<sup>th</sup> minutes of the Hanson-McCook Regional Library were noted and filed.

Tracy Hofer, Zoning Administrator, presented a plat for approval. Motion made by Smith to approve Plat of Tracts 1 & 2 Snyder's Addition in the Northeast Quarter of Section 29, Township 103 North, Range 53 West of the 5<sup>TH</sup> Principal Meridian, McCook County, South Dakota. Second made by Dybdahl and motion carried.

Auditor Sherman, Mariann Oyen, Benefits Specialist, and the Commissioners reviewed Care of Poor cases. A Notice of Hospitalization was received from Avera McKennan Hospital (2014-34). A Notice of Hospitalization was received from Sanford USD Medical Center (2014-35). Three claims were sent to Dept of Social Services for Medicaid pricing (2013-30, 2013-41 and 2013-45). An individual who applied for county assistance has withdrawn the application due to pending Medicaid application (2013-27, 2013-31 and 2013-33).

Auditor Sherman asked the Commission to again review the 2015 budget requests prior to publication of the Provisional Budget. At this time, a \$600 annual pay increase will be figured into the budgets for all FT employees.
