The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Ralph Dybdahl. Members present: Marc Dick, Ron Scharffenberg, Steve Gordon and Sheldon Butzke.

Chairman Dybdahl led the Pledge of Allegiance.

Chairman Dybdahl called for approval of the Agenda. Motion made by Scharffenberg to approve the Agenda as posted. Second Gordon and motion carried.

Commissioner Reports: Commissioners Butzke and Dick and Hwy Supt Kreutzfeldt attended a tiling clinic held in Brookings.

Hwy Supt, Mic Kreutzfeldt, and the Commissioners discussed SB2 which provides for establishment of river basin natural resource districts and repeals certain provisions regarding county drainage management and SB1 which deals with finance improvements on public highways and bridges by establishing or increasing certain fees. Kreutzfeldt noted that spring load limits will go into effect today, as the County follows SDDOT recommendations for this area. Kreutzfeldt presented culvert inspection information/findings. There are a total of 1054 culverts crossing county roads and 168 culverts that are cost shared with Townships. At this time, 75 culverts need to be repaired or replaced.

Motion made by Butzke to convene as Drainage Commission.

Drainage Administrator Kreutzfeldt presented a drainage permit application, noting that downstream landowner signatures were obtained and he has signed off on it:
