The meeting of the McCook County Commission was called to order in their Meeting Room by Chairman Sheldon Butzke. Members present: Ron Scharffenberg, Ralph Dybdahl, Bill Smith, Marc Dick.

Chairman Butzke led the Pledge of Allegiance.

Chairman Butzke called for approval of the Agenda. Motion made by Dybdahl to approve the Agenda. Second Smith and motion carried.

Courthouse parking lot project discussed. Kreutzfeldt noted that load limits will be in place on Thursday, March 8th following SD DOT.

Motion made by Scharffenberg to convene as Drainage Commission. Second Dybdahl and motion carried.

Drainage Adm Kreutzfeldt reported that progress has been made on Permit D11-113 (Larry Kappenman) drainage project option. Kreutzfeldt noted that Ron Addy has requested a hearing for Permit D12-003, legal description NW4 Ex S972.5' of W1120' thereof 21-102-54 and NE4 W of RR Inc W 50' former RR R-O-W 21-102-54, due to lack of downstream acceptance signatures. Motion made by Dick to set 9:30 a.m. on April 3rd, as time for drainage hearing. Second Smith and motion carried. Kreutzfeldt informed the Board of computer issues caused by the 2007 drainage permit numbering system and plans to renumber and send copies to the 28 applicants with the new permit number.

The Board reconvened as Board of County Commissioners.

Winny Jo Jons, Rural Office of Community Service, discussed transit options and funding for same for county residents with the Commission. Dybdahl will check with Inter-Lakes Community Action to see if this is a service offered by them.

Motion made by Dybdahl to convene as Planning Commission. Second Smith and motion carried.

Zoning Administrator, Tracy Hofer, presented a plat for approval. Motion made by Dybdahl to approve Plat of Tract 1 Butzke's Addition in the East Half (E ½) of the Northeast Quarter (NE ¼) of Section 14, Township 104 North, Range 56 West of the 5TH P.M., McCook County, South Dakota. Second Smith and motion carried.

The Board reconvened as Board of County Commissioners.

Carol Lauer, Treasurer, presented a list of seventeen (17) parcels that are ready for tax deed proceedings. The Advance Taxes and Escrow lists were also noted. Lauer presented this request from Tal Parante, property owner of Lots 5 thru 12, Blk 11, OT Bridgewater, regarding delinquent property taxes dating back to 2007: I would like to have the following proposition placed in front of the McCook County Commissioners-\$2500 first payment and \$500 thereafter per month until the debt is retired. These are the only options at my disposal as I have lost my business due to a down turn in the economy and am trying my best to repay my debts. Your consideration is greatly appreciated. Lauer noted that this property is ready for tax deed taking. Scharffenberg noted that there are individuals who have an interest purchasing this property. Smith and Dick stated that they are not in favor of setting up a payment plan. Don't appreciate Parante waiting five years and now wants to make a deal. Motion made by Dybdahl to table decision on accepting Parante proposal until the March 20th meeting allowing Scharffenberg time to contact the parties interested in purchasing the property. Second Smith and motion carried.

Kevin Blagg met with the Board for signing of the Memorandum of Understanding between SDSU Extension and Counties of South Dakota 2012. The reference to the 4-H Promotion and Expansion Committee designee approving expense vouchers for the 4-H Advisor was crossed out of the agreement as this committee is advisory only. With this noted, motion was made by Smith to authorize Chairman Butzke and Committee member Blagg to sign the MOU. Second Dybdahl and motion

carried. Auditor Sherman presented the 2012 Promotion and Expansion Committee member list from Alicia Reif, 4-H Advisor: 4-H Adults: Kevin Blagg, Carie Stiefvater, Bernice Schallenkamp; 4-H Teens: Francis Tusha, Miranda Wilkinson, Caleb Wobig; Non 4-H Adults: Deb Eichacker, Terry Rieckman, Bill Smith; Non 4-H Youth: Ben Whistler, Brandon Reif, Lauren Miller.

Auditor Sherman, Mariann Oyen, Benefits Specialist, and the Commissioners reviewed Care of Poor cases. Received two Notices of Hospitalization from Sanford Medical Center; one 1 for a Minnehaha County resident which was returned to hospital. One Notice of Hospitalization was received from Avera McKennan Hospital. Two Applications for County Assistance for prescription drugs were received. Sherman noted that she did confer with physician regarding both applications; one was approved and one denied. Lien payments received in February for court appt attorney claims and care of poor claims were noted.

Ron Pringle met with the Board to ask what can be done to put county owned property back on the tax rolls. Scharffenberg suggested an easement for the building owned by Christine & Christopher Duerksen which is partially located on county property. Pringle noted that he'd like to see the property in private ownership. Motion made by Scharffenberg to ask States Attorney Gerlach to draw up an encroachment easement allowing existing building to remain as is, but when it no longer exists another building cannot be placed in same area. Second Dybdahl and motion carried.

Scharffenberg left the meeting at this time.

Mic Kreutzfeldt, Hwy Supt, introduced Tim Johnson, Gasrite, who presented options for purchase of fuels with the Board.

The January 17th minutes of the Hanson-McCook Regional Library meeting were noted and filed.

Motion made by Smith to authorize Chairman Butzke to sign 2 original copies of FY2012 WIC Contract Amendment. The amended contract amount is \$5799.00. Second Dick and motion carried.
