April 25, 2023

The meeting of the McCook County Commission was called to order in their Meeting Room by Vice-Chairman Charles Liesinger. Members present: Chuck Mehlbrech, Dean Koch, and Steve Gordon. Member absent: Marc Dick.

Vice-Chairman Liesinger led the Pledge of Allegiance.

Vice-Chairman Liesinger called for approval of the agenda. Auditor Sherman noted the addition of Equalization Board for two valuation adjustments. Motion made by Koch to approve the agenda adding at the end of the agenda. Second Mehlbrech. Motion carried.

The minutes from the April 11th meeting were sent to Board members for review prior to publication. Motion made by Gordon to approve the minutes for publication. Second Mehlbrech. Motion carried.

Chairman Dick joined the meeting.

Public input: Roger Hofer asked if commission members read an article in The Special regarding a Vermillion Basin Water Development District meeting, asking why taxpayers are paying for a City of Vermillion project? Auditor Sherman explained that the municipalities within the VBWWD are eligible to apply for project funding. With McCook County becoming a member of the district, our municipalities may also apply for project funding, it's the way the district is set up. A few of the projects include ground water studies, watershed protection & restoration, engineering studies, and water quality & quantity studies, to name a few.

Commissioner Reports: Mehlbrech and Gordon attended the Commissioners Spring Workshop held in Pierre.

Conflict of Interest: none noted.

Missy? was present to watch the meeting process.

Mic Kreutzfeldt, Hwy Supt, and Travis Raap, Hwy Supt (to be), met with the Commission. Kreutzfeldt presented the engineering proposal from IMEG for structural design for bridge to be replaced on 448th Ave, total \$73124.20. Motion made by Gordon to authorize Kreutzfeldt to sign-off on the agreement with IMEG. Second Liesinger. Motion carried. Kreutzfeldt and Board revisited radio replacements. Kreutzfeldt thanked Comm Koch for input/assistance. The Hwy Dept could get by with 11 radios, hoping 5 radios from EM are reprogrammable if employees used personal phones for communication & data entry. Raap noted that the use of cell phones will be beneficial, and a stipend would be less expensive than purchasing 24 radios. Auditor Sherman added that a cell phone policy can be discussed with Michelle Stubkjaer, HR Consultant, noting that other employees use their personal cell phones for county/office business, so may need to offer to others. Motion made by Koch to pay \$25 stipend/month to Hwy Dept employees for use of their personal cell phones and utilize 11 radios for communication purposes. Second Mehlbrech. Motion carried. This will be revisited as needed. Kreutzfeldt informed the Board that bridge 44-210-227 N of Monroe was hit and the rail was torn off; \$9800 for Holloway Construction to make repairs. Kreutzfeldt asked the Board if they want the west property seeded down, to keep the weeds down. Yes. Kreutzfeldt informed the Board that, going forward, Puetz Design will charge \$90/hour for designer & \$120/hour for architect work to finish changes. Raap reported that the operation & repair training on the Entyre chip spreader/distributor was very beneficial. Current projects include pulling shoulders, ditch cleanouts & patching, and weed spraying, soon. Load limits have been lifted.

Chairman Dick read letter of resignation from Kreutzfeldt. Motion made by Gordon to accept resignation of full-time status effective June 23, 2023, with transition to a part-time role. Second Koch. Motion carried.

Motion made by Liesinger to convene as Drainage Commission. Second Gordon. Motion carried.

Mic Kreutzfeldt, Drainage Administrator, presented a drainage permit application to the Board, noting that downstream landowner signatures were obtained, and he has signed off on it. All permits are available for inspection at the Hwy Dept Office.

Anna Flogstad, Staff Appraiser, presented two plats to the Board for approval. Following review of the Plat Review forms, motion was made by Liesinger to approve the 1st plat. Second Mehlbrech. Motion carried.

The Board reconvened as Board of County Commissioners.

Sheriff, Mark Norris, informed the Board that all but one open position has been filled within the law enforcement department.

Norris told the Board that from January 1st through March 31st, there have been 51 drug arrests, 15 of them felonies. Norris would like to bring a drug dog back into the force and apply for a \$9000 grant: \$7800 for a dog and \$1200 for a hot dog unit for the vehicle. Liesinger and Koch noted that they don't like the idea based on past experience. Norris agreed but added there would be a different handler now.

Mehlbrech, Gordon, and Dick feel it's a good idea. Dick suggested putting a time limit of 2 years on this and re-evaluate. Norris told the Board that he already applied for the grant and the application was approved (he has a \$9000 check), now he needs Board approval to move forward. Motion made by Mehlbrech, to purchase a drug dog and a hot dog unit for the vehicle, through the grant process. Second Dick. Motion carried.

Geralyn Sherman, Welfare Director, and the Commissioners reviewed a Care of Poor case. Avera McKennan is appealing the County decision to deny payment because the individual was offered health insurance through employment (2022-31).
